

## **Terms and Conditions**

**Reservations:** Reservations are secured with a deposit of \$500 US per person paid with a personal check, money order or cashier's check in US dollars. The balance must be received 60 days prior to departure. We welcome last minute bookings, however if your reservations are made less than 60 days from the departure date of a trip, full payment is required. The checks should be made out to F/V Aimee O, Inc. and included with the other documents returned to F/V Aimee O. The 8-day course fee is \$2,850 per person.

**Cancellations:** Because plans can change which necessitate canceling your trip, we strongly recommend purchasing travel insurance. Please notify us as soon as possible if you must cancel your reservation. The following policy will apply once we receive written notice of cancellation:

- 120+ days prior to departure: Full refund of the deposit.
- 120 – 61 days prior to departure: Forfeiture of the deposit
- 60 – 31 days prior to departure: Forfeiture of 50% of the cost of the trip
- 30 – 0 days prior to departure: Forfeiture of 100% of the cost of the trip
- 
- If we are able to rebook the reservation, a full refund will be issued for any cancellations.
- There is no charge for rebooking to another trip if space is available.

**Inclusions:** The cost of the trip covers accommodations, meals with wine/beer and special use permits for the duration of the trip booked. The use of fishing tackle and bait, crab and shrimp pots, and all recreational crafts for excursions such as kayaks, rowing dory and inflatable raft is also included.

**Exclusions:** All costs associated with air transportation and land accommodations/meals, including additional expenses incurred because of delays due to weather, illness, aeronautical mechanical problems and geopolitical situations beyond our control are not included in the cost of our charters. We recommend travel insurance to cover these situations. Fishing licenses are not included.

**Smoking:** Smoking is not allowed in any of the enclosed areas of the vessel. Guests may smoke in designated outside areas only.

**Medical/Health:** When a deposit is made, the guest certifies that he/she does not have any mental, physical or other conditions of disability which would create a hazard for him/herself or other guests. Because medical facilities are not readily available, guests with medical conditions or restrictions must let us know well in advance in writing. We reserve the right to restrict participation in an activity or of a trip if we consider a guest physically incapable and/or if a guest's continued participation jeopardizes the group's or his/her own safety. Under these circumstances refunds are not given.

**Changes:** We reserve the right to make reasonable changes in the itinerary or crew or substitute modes of transportation where deemed advisable for the comfort and safety of our guests. If for any reason, F/V Aimee O, Inc must cancel a trip, a full refund will be issued.
